

2014 in Review

- Carver County continued AIS inspections at Lake Minnewashta Regional Park
  - 100% watercraft inspection at LM Regional Park from May 15 through September 15
  - Managed by Carver County Parks department
  - Carver County and the Minnehaha Creek
     Watershed District shared the cost
  - Two boats with zebra mussels were detected and turned away

- The LMPA delivered on a broad education and awareness outreach in 2014
  - Quarterly LMPA Newsletters and email blasts
  - Website and social media campaigns
  - Traditional media outreach

#### Invasive Weed Treatments Performed

- Late spring and heavy rains led to record water levels so weeds emerged late this year and were less prevalent than normal
- Scot Lacek and Pete Plucinak continued their diligent permit/grant and execution management
- Low dosage weed treatment strategy enacted for the last years appears to be reducing the levels of milfoil 
   Much smaller weed treatment performed
- Weed levels were very acceptable as a result

## Water Quality/Clarity level has degraded

- Lake grade was at B+ in 2014
- Enhanced effort is needed to address the causes of this drop
- Many elements may be contributing to this drop and we have to understand them before we can be address them

- Minnesota Statewide Legacy funding has begun to flow to our Counties for Natural Resource improvement
  - Carver County will receive >\$50,000 in 2014 and more in 2015
  - Purchase of Watercraft Decontamination System (high temperature power washer) has been requested by Carver County

- The LMPA Continues its active support of the Coalition of Minnehaha Creek Waters (CMCW)
  - The Coalition's purpose
    - Support and conduct non-partisan research, education, and informational activities to increase public awareness and support for the health and usage of the Minnehaha Creek Watershed and surrounding area waters
    - Share best practices (e.g. Lake management plans)
    - Collaborate for a louder voice to policy makers
  - Primary focus is on AIS and storm water run off
  - Steve Aldritt is serving as the secretary

- Improved communication within the LMPA
  - Continuing the use of Neighborhood Captains
    - Surrounding area broken into neighborhoods
    - Identified leaders to serve as Captains to enhance communication with moderate success
  - Continue the use of Constant Contact, Facebook, and our website to flow information
  - Adding "NextDoor" Neighborhoods to expand inter-resident communication

- Our focus for 2015 will be on
  - Our Aquatic Invasive Species Prevention Plan
  - Aggressive weed treatment
  - Enhanced focus on water quality/clarity
  - Lake Stewardship Education and awareness
  - Enhanced LMPA Membership benefits and involvement

#### Invasive Weed Treatment

- Our low dosage weed treatment plan seems to be working by reducing the acreage of the lake needing treatment each year
- In 2015 we hope to address the Curly Leaf Pondweed early growth separately and earlier
- Contributions will dictate whether we can do it
  - We need to raise \$11,000 (minimum)
  - We hope to secure a grant from the DNR for \$4000
- We will schedule a treatment of frequently used common areas as soon as possible

#### Zebra Mussel/AIS Prevention Plans

#### ONGOING PLAN

- Secure resources for watercraft inspection beyond 2015
- Support purchasing a Carver County Decontamination Unit
- Help drive action from the Watershed, County & State

#### **PUBLIC AWARENESS:**

- Deploy a broad education and awareness campaign for Invasive Species in the community again
  - Primary Audience Lake residents and current lake users
  - Secondary Media, future users/young adults, lake service professionals
  - Tertiary Key local decision makers and elected officials.
- DNR Funding requested for Gas Station advertising

- Water quality/clarity Improvement
  - Aggressive push planned on improving our Lake Quality
     Rating from B+ to A
    - Fall Leaf disposal strategy to be developed
    - Increased effort on landscaping and buffering
    - Runoff reduction
    - Carp population
  - We need a volunteer coordinator to focus on this

- Grow the Collective Voice of Lake Association Coalitions Around the state
  - Continue the further growth of the CMCW
  - Identify common issues that are of most importance to lake users and residents
  - Share best practices (e.g. Lake management plans)
  - Leverage Statewide via MNCOLA
  - Collaborate for a louder voice to policy makers
